
SMART TIME

WinLine SMART TIME is the intelligent time recording software, supporting you with conformance to the findings of the European Court of Justice (CJEU) of May 2019 (C-55/18), which require employers in EU member states to systematically record and document their employee working times.

Use the WinLine SMART TIME module to record employee presence and absence times, including related feedback confirmations. Work schedules can be set up directly in WinLine. Add the WinLine SMART VACATION module and you always have up-to-date information when your employees are on vacation or are absent due to other reasons.

By means of another add-on, the project time entry features in the WinLine PROJECT module can be made available, as well. And finally, the WinLine SMART TIME module can be interfaced to time recording terminals.

WinLine SMART TIME is a purely software solution, which can be used on PCs, tablets or smartphones. No additional hardware is thus required. Data from time recording terminals can be directly imported into the time recording software.

SMART SCORE

Implementation of gamification concepts is the core of the WinLine SMART SCORE module. Using various kinds of gamification components, it is possible to visualize the level of achievement for planned goals, thus promoting and enhancing employee motivation.

One-time or periodically achievable "Goals" can be set up in WinLine, which are evaluated based on metrics representing nearly any kind of raw data, e.g., sales or CRM activities. "Goals" can be of the "one-off" type, to be achieved once and thus completed, or of the "recurring" type, i.e., targets that are continuously measured and calibrated on a periodic basis.

Achieved goals represent milestones, marking the path to the eventual targets in the long-term. Milestones let the user visualize how close they are to achieving a particular goal, i.e, whether it be weeks, months, or even years in the future.

Ranking lists in WinLine SMART SCORE let users see their current level of goal achievement. This gives them the opportunity to compare their achievements in a game environment with other users in the ranking list.

The WinLine BI module is required for the use of WinLine SMART SCORE.



SMART VIDEO

Direct in WinLine: Video and audio conferencing with one or more SMART users is provided with the WinLine SMART VIDEO module. Using the built-in chat functions you can share text messages with other WinLine SMART users directly during online conferencing. All communication is encrypted and conforms to current data protection regulations.



SMART GDPR

This module with its comprehensive features facilitates handling of personal data in WinLine in conformance with current regulatory requirements.
